## **Guidelines:**

- All requests are subject to review and approval by Ashley Kane, Manager, Child Life Program. Items may be substituted when a suitable alternative is located within child life stock items from donations (example: crayons).
- Furniture or other items deemed as appropriate for hospital operating or capital budget will not be approved (i.e. child-size table/chairs for waiting room, minor equipment items)
- Due to Cyber Security and current IT regulations, iPads and other electronics which can connect to the Internet may not be requested through this process.
- Child Life Specialists are available to assist with assessment of existing spaces and resources to provide recommendations. - Whenever possible, requested and approved items will be shipped directly to the clinic or practice site location requesting the items. Please provide accurate delivery address and any additional information in the application request.
- Requests will be accepted from pediatric clinics, practice sites, and clinical areas where child life is not presently staffed. If you have a child life staff member working in your area, please talk with them about any perceived needs you may have.
